Impacted organizations include subcontractors working for prime contractors or other subcontractors.

NIST 800-171 (first published June 2015)

Provides guidance as to how Controlled Unclassified Information (CUI) should be accessed, shared, and stored in a secure fashion

CMMC (first published January 2020)

A unified cybersecurity standard created to increase the security posture of the Defense Industrial Base (DIB)

GET READY FOR CMMC

The Department of Defense is gradually transitioning from the NIST 800-171 mandate to the CMMC framework. By October 1, 2025, all new DoD contracts will require compliance with CMMC.

Depending on the level of CMMC to which you need to comply, you can either self-attest to compliance or you may require an assessment by a CMMC Third Party Assessment Organization (C3PAO) or the government.

NIST Assessments
